



Before filling out this form, please carefully read the following general information about the Spanish Financial Forum in Luxembourg (SFF)

- **To be a member** of the Official Spanish Chamber of Commerce in Belgium and Luxembourg (hereafter, "the Chamber") in any of its categories as well as keeping up-to-date with membership payments are an **essential requirement** to applying for accession to the Spanish Financial Forum in Luxembourg (hereafter, "SFF"). No joining fee to the SFF is applied.
- The registration form must be completed by the main contact of the company member (corporate member) for the relations with the Chamber. Such contact **may appoint up to three employees** to represent their company in SFF internal meetings. Preferably, the different representatives of the same company should be specialized in different working areas and in relation to the Spanish&Luxembourgish markets.
- Each company may apply to lead one of the four sub-sectors: Banking, Asset Management, Tax, Insurances. The appointment of the leaders of each sub-sector is personal (main contact of the company to the SFF) and will be made on the basis of previously established objective criteria such as:
 - Experience of the candidate in the sector.
 - Proposal of activities and initiatives to develop within the framework of the SFF.
 - Readiness to coordinate the sub-sector among the rest of the group members
 - Applications from sponsor members will have priority over the rest of the categories

This list is not exhaustive. The applications will be submitted to the Board of Directors in Luxembourg who must ratify the appointments. For this first stage, the duration of the appointments will be 12 months, to be counted from the date of ratification. After that, members of the SFF must agree on a voting process for successive appointments.
